The scope of the processed data is set out in the Rental Agreement. Personal data is processed solely for purposes necessary to perform the Rental Agreement, including accounting purposes related to documenting the settlement of the Agreement. The data is processed for the period necessary to perform the Rental Agreement, including satisfying any claims arising from it, until the expiry of the obligation to retain accounting documentation as specified in the provisions of the Act. The data is secured and protected against access by unauthorised persons.

The legal bases for processing your personal data are Article 6(1)(a) (consent to data processing) and (b) of the GDPR (processing necessary for the performance of the Agreement to which you are a party).

Where data is collected directly from the data subject, the provision of personal data is voluntary. As regards the remaining scope, in respect of some contact data, it has been obtained from publicly available sources.

The data subject has the right to withdraw consent to the processing of personal data, the right of access to the data (including the right to receive a copy of it), the right to rectification of the data, the right to erasure of the data, the right to restriction of processing, the right to object to processing, the right to data portability and the right to lodge a complaint with a supervisory authority.
